

**Kobo's Designed With Love Contest, March 18, 2013 – March 29, 2013**

**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO PARTICIPATE OR RECEIVE PRIZES. PURCHASE OR ACCEPTANCE OF A PRODUCT OFFER DOES NOT IMPROVE YOUR CHANCES OF WINNING.**

**SPONSORED BY**

**CONTEST PERIOD**

The Kobo's Designed with Love (the "Contest") submission begins on March 18 at 12:00:01 a.m. Eastern Standard Time ("EST") and ends on March 29 at 11:59:59 p.m. EST (the "Contest Period"). The Sponsor's servers are the official time keeping device for this Contest. The time that an Entry is received by the Sponsor will be the time at which it is received by the Sponsor's mail server or web server (as applicable) as determined in accordance with the applicable server's clock.

**ELIGIBILITY**

The Contest is open only to legal residents of the forty eight (48) contiguous United States, District of Columbia and Canada (excluding Quebec) who have reached the age of majority in their respective jurisdiction at the time of entry (each entrant, an "Entrant"). Void in Guam, Puerto Rico, the U.S. Virgin Islands, Quebec, and where prohibited by law. Employees of Sponsors or any of its respective affiliates, subsidiaries, advertising agencies, representatives, agents, or any other company or individual involved with the design, production, execution or distribution of the Contest and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of each such employee are not eligible. Participation constitutes Entrant's full and unconditional agreement to these Official Rules and the Sponsors' decisions, which, subject to applicable law, are final and binding in all matters related to the Contest. - b.) Create a new board of your own called "Designed with Love".
- c.) Re-pin from the Kobo contest board (i) the Kobo Fashion Week video, and (ii) the handmade Kobo Arc case mosaic from our contest board to your board.
- d.) Complete your board with two fashion books from Kobo.com.
- e.) Comment on the contest pin with the link to your "Designed with Love" board to enter (all steps collectively, an "Entry").

All Entries must be received before 11:59 pm, EST March 29, 2013. Limit is one Entry per Entrant for the Contest, regardless of email address provided. Entries that exceed this limit will invalidate all Entries previously made by that Entrant.

## ENTRY VERIFICATION

If the identity of an Entrant is disputed, the Entrant will be deemed to be the name on the Entry. An Entrant may be required to provide proof that he/she is the authorized account holder of the Pinterest account associated with the winning Entry.

Entries are subject to verification and may be disqualified if they are late, misdirected, incomplete, illegible, irregular, submitted through illicit means, not original to the Entrant, or if they contain any false statements or do not conform to or satisfy any condition of these Official Rules. No mechanically reproduced, illegible, or incomplete Entries will be accepted. The use of any device to automate the entry process is prohibited; entries must be manually key-stroked. The Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Contest.

## OWNERSHIP OF ENTRY

Entrant agrees that Sponsor will have a perpetual and irrevocable license and right to reproduce, use, exhibit, display, adapt, broadcast and distribute and create derivative works of the Entry in any media now known or later developed, throughout the world. Submission of the Entry is a waiver of any right to inspect or approve the use of the Entry, as well as a waiver of any "moral rights" or right to royalties or other compensation arising from or related to the use of the Entry.

## PRIZE DESCRIPTION

Seven (7) winners will be awarded one (1) of seven (7) Kobo eReaders Arc Edition, each with an approximate retail value of \$199.99 CAD, with a one-of-a-kind Kobo Arc case hand crafted by one of THE COLLECTIONS designers.

Prize must be accepted as awarded. Prize is not convertible to cash. The Sponsor reserves the right to substitute the prize in whole or in part for any reason whatsoever with a prize item or cash of equal or greater value. Taxes and fees, if any, are the sole responsibility of prize winner. Additional restrictions, conditions and limitations may apply. Sponsor is responsible only for prize delivery and is not responsible for prize utility or otherwise.

#### PRIZE DRAW

Odds of winning depend on the number of eligible entries received and the quality of the Entrant's board, as determined based on the Judging Criteria (as defined herein). Seven (7) winners will be chosen by Kobo's Marketing and Public Relations teams based on the creativity of their boards (the "Judging Criteria"). The winners will be announced on Kobo's Pinterest, Facebook, and Twitter pages on April 1, 2013. If a winner does not contact Kobo in accordance with the Official Rules or a winner does not comply with the Official Rules, he/she will be disqualified and will not receive a prize. Winners who answer a skill testing question correctly via email will be sent their prize on or before April 30, 2013 to the address stipulated by the winner.

#### ENTRY CONDITIONS AND RELEASE

## GENERAL CONDITIONS

The Sponsor reserves the right to cancel, suspend and/or modify the Contest, or any part of it, including these Official Rules if any fraud, technical failures or any other factor beyond the Sponsor's reasonable control impairs the integrity or proper functioning of the Contest, as determined by the Sponsor in its sole discretion. If for any reason the Sponsor is unable to fully operate the Contest as set out in these Official Rules, the Sponsor, at its discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

## LIMITATIONS OF LIABILITY

The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by Entrant, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Contest; (4) technical or human error which may occur in the administration of the Contest or the processing of entries. If for any reason an Entrant's Entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, Entrant's sole remedy is another Entry in the Contest, if possible. No more than the stated number of prizes will be awarded. By entering the Contest, the courts of the Province of Ontario, Canada shall have jurisdiction to entertain any action or other legal proceedings based on any provision of these Official Rules or the running of this Contest.
